

# CEEA-ACÉG Lifetime Service Award

## NOMINATION DEADLINE: APRIL 15

This award recognizes those individuals who have, over the span of at least 15 years, contributed significantly to the development of engineering education and or engineering research in Canada, and have been significantly committed to the CEEA-ACÉG community. This award will only be granted when the Nominations and Awards Committee (NAC) and the CEEA-ACÉG Board believe that a worthy candidate has been nominated (i.e., the award may not be granted every year).

*Championing the field of engineering education through innovation and research and service is critical to the development of the profession and field and requires one to be courageous. Innovation, research, and service in engineering education are the agents of improvement and change. Advancing a field over one's career is a worthy endeavor worth noting and celebrating. Thus, our community honours lifetime achievement in engineering education and service through our CEEA-ACÉG Lifetime Service Award!*

### Eligibility criteria:

- Individuals who have played an active role (including significant leadership) in engineering education in Canada over at least 15 years, including significant and sustained contributions and service to CEEA-ACÉG

### Selection criteria:

#### **The Board will render its decision based on the nominee's:**

- Length of service in engineering education in Canada
- Cumulative length of service to CEEA-ACÉG
- Impact of service on engineering education in Canada
- Impact of service on CEEA-ACÉG
- The comparability of service relative to previous award winners

### Award:

When granted, one or more awards shall be given at the CEEA-ACÉG Annual Conference Banquet, signified by an engraved plaque (CEEA-ACÉG Emeritus status), recognition on the CEEA-ACÉG website, and lifetime CEEA-ACÉG membership. They will also receive waived conference registration fees for the year the award is given and a conference travel stipend of up to \$500 (if needed, with receipts). The recipient will be invited to give a short speech at the CEEA-ACÉG Annual Conference Banquet in the same year the award is given.

### Process of Selection:

The community of CEEA-ACÉG Fellows will meet annually to recommend one or more nominees. Fellows will create a short file describing each nominee's contributions including a summary of:

- Contributions to the development of engineering education and/or engineering education research in Canada
- Ways in which the nominee has been committed to and served the CEEA-ACÉG NAC will make a recommendation to the CEEA-ACÉG Board

NAC will review the nomination package(s) and make a recommendation to the CEEA-ACÉG Board

The Board will render a final decision based on the nominee's file and the NAC's recommendation

Nominees whose applications are rejected can be nominated again in future years
